

PERSONAL DATA PROCESSING STATEMENT

Involved Subjects: Customers.

IT TIME sa, as Holder of the processing of your personal data, in conformity and for the effects of the federal law on data protection (LPD), which has been in force since 1 July 1993, hereinafter 'LPD', informs You that the said law provides for the protection of persons and other subjects regarding the processing of personal data and that such treatment will be based on principles of correctness, lawfulness, transparency and protection of Your privacy and Your rights.

Your personal data will be processed in accordance with the laws of the above mentioned legislation and of the confidentiality obligations as provided herein.

Aims of treatment: in particular, your data will be processed for purposes related to the implementation of the following tasks, relating to legislative or contractual obligations:

- Enforcement of laws relating to money laundering legislation
- Compliance required by law in the tax and accounting
- After-sale assistance
- Contentious management
- Customer management
- Quality management
- Requirements of the law
- Planning activities
- Survey of the degree of customer satisfaction;
- Historic billing to customers.

The treatment of operating data for the completion of these requirements is necessary for the proper management of the relationship, and their contribution is required to achieve the purposes outlined above. Your personal data may also, with your consent, be used for the following purposes:

Contribution of data is up to You concerning the above purposes, and Your eventual refusal to treatment does not affect the continuation of the relationship or the respect of the same.

Treatment modalities: your personal data may be processed in the following ways:

- Outsourcing of processing operations;
- Creation customers, suppliers or consumers profiles;
- Treatment by computer;
- Manual processing through paper files;
- Data audits and modifications only on official request of party.

Each treatment takes place in accordance with the procedures described in the LPD and through the adoption of minimum security measures provided.

Right of access to personal data and other rights

1. You have the right to obtain confirmation of existence or not of personal data concerning You, even if not yet recorded, and their communication in intelligible form.
2. You have the right to know:
 - a) origination of personal data;
 - b) purposes and methods of treatment;
 - c) logic applied in case of data processing with electronic instruments;
 - d) identity of the holder and the designated representative;
 - e) subjects or categories of persons to whom the data may be communicated or who can learn about them as appointed representative in the State, as managers or agents.
3. You have the right to obtain:
 - a) updating, rectification or, when necessary, integration of data;
 - b) cancellation, transformation into anonymous form or block of data processed unlawfully, including those whose retention is unnecessary for the purposes for which data were collected or subsequently processed;
 - c) certification that the operations in letters a) and b) have been notified, also regarding their contents, to those to whom the data were communicated or spread, unless this requirement proves impossible or involves a manifestly disproportion of means in relation to the protected right.
4. You have the right to object, in whole or in part:
 - a) for legitimate reasons the processing of personal data, even if pertinent to the purpose of collection;
 - b) the processing of personal data for the purpose of sending advertising materials or direct selling or for carrying out market surveys or commercial communication.
